- Willingness to collaborate with the department in reviewing and establishing equitable grading practices to assess student writing.
- Eagerness to work collaboratively with the Humanities departments to develop interdisciplinary learning opportunities.

**Responsibilities:**

- Course load: 5 sections of 6<sup>th</sup>/7<sup>th</sup>/8<sup>th</sup> grade Literature
- Preparation of course materials and assessments, both working from existing curricular frameworks and through the development of new materials.

- Willingness to serve as an advisor to a small group of students.
- Participate in an after-school (3:30–5:30 p.m.) program two days a week (sports, clubs, performing arts, academic support, etc.).
- Attend regular community gatherings, including, but not limited to, meetings, Chapel, lunch, and major Feast Days.

- Bachelor's degree in History, Ethnic Studies, or a related field.
- A desire to work in a creative, collaborative, innovative environment.
- Strong leadership and organizational skills.
- Candidates will preferably have a master's degree in a relevant field of study, 3+ years of teaching experience, or a CA teaching credential.
- Covid vaccine and Covid booster required
